Uncertainty visualization in TEI documents | The main focus of the PROVIDEDH project is geared toward the creation of visualization systems, that aid in the handling of uncertainty in Digital Humanities datasets. Our tools on the collaborative platform were developed against the background of human-centered design, with a focus on easing uncertainty annotation and visualization, promoting the use of TEI standards and making uncertainty play a more active role in the research process.


Multi-user system with support for uncertainty annotations | Our platform allows users to create research projects, upload batches of TEI files, annotate these files concurrently by multiple users, as well as identify and manage the entities appearing in the files. Users are able to create their own taxonomies of uncertainty or use the default one to make annotations. All annotations and unifications made on the platform can be rendered then to the TEI format. The users do not need to be familiar with TEI, as our platform provides them a friendly interface for annotating electronic texts. This allows a variety of users to use the platform in ways suitable to their various needs and datasets.

Automatic detection of different instances of the same entity | One of the functionalities of the platform is Entity Normalization. To achieve this, the system employs a neural network and weighted multigraphs approach to recognize entities appearing in the TEI files under different identifiers and to suggest unifications when certain similarities are detected. In the multigraphs, the nodes (representing entities) are connected by edges constructed and weighted by metadata analysis. The composition of metadata set depends on the type of entity; for a "person" it is, among others: forename, surname, gender, dates, mentions' context and mutual acquaintances — i.e. co-occurrence of unified people in the same files of the dataset.

Supporting decision-making in the unification of entities | The result of the entity normalization task can also be presented in the form of a graph, in which the nodes (representing entities and cliques of already unified entities) are connected by three types of edges. Purple edges show the proposed unifications between entities and cliques — the thickness of these edges illustrates the system confidence for the unification. Grey edges show co-occurrence of entities in one file, and turquoise edges show entities belonging to a clique. The system presents each of the proposed unifications together with the context of the occurrence of entities being unified, where the user can reject or accept it. In case of acceptance, the user must express their confidence of the unification. The system learns from users' actions and subsequent runs of the algorithm take the rejected and accepted unifications into account.


